### Healthcare Expenses that Qualify for Reimbursement under the Flexible Spending Account Plan \*

### Over-the-Counter Items Requiring a Physician's Prescription/Letter Indicating Medically Necessary

Antibiotic products	Cough, cold & flu meds	Respiratory treatments
Anti-diarrheas	Digestive aids	Sleep aids and sedatives
Anti-gas relievers	Feminine anti-fungal/anti-itch	Stomach remedies

### Healthcare Expenses That Will NOT Qualify for Reimbursement Under FSA

Cosmetic surgery and procedures
Dental bleaching
Health club or gym memberships for general health purposes
Hair restoration including procedures, drugs or meds
Late fees incurred
Marriage and family counseling
Mail-order Rx's from another country
Weight loss programs for general health
Premiums you or your spouse pay for insurance coverage are not reimbursable if they are pre-taxed through your company sponsored premium only plan
